

Question: Do a comparative study of the Parliamentary system of Britain and the Presidential system of America.

Answer:

Britain and the USA are both democratic nations, but their systems of governance are distinct. Britain follows a parliamentary system, whereas the USA follows a presidential system. The features, functioning, and key differences between these two systems can be understood through the following points.

1. Features of the Parliamentary System in Britain

The parliamentary system in Britain is also known as the Westminster Model. Its key characteristics are:

1. **Constitutional Monarchy** – Britain is a constitutional monarchy where the King (currently King Charles III) is the formal head of state, but real power lies with the Parliament and the Prime Minister.

4. **Close Relationship between the Executive and the Legislature** – The executive (government) is directly accountable to Parliament. If it loses the majority's confidence, it must resign.
5. **Bicameral Legislature** – The British Parliament consists of two houses:

House of Commons – Members are directly elected by the people and hold the real power.

House of Lords – Members are appointed and play an advisory role.

6. **Majority Rule** – The ruling party must have a majority in the House of Commons to govern effectively.

7. **Party-Based Politics** – Political parties play a crucial role, and party discipline is strictly maintained.

2. Features of the Presidential System in the USA

The USA follows a constitutional republic with a presidential system. Its key features include:

1. **Supremacy of the Constitution** – The written constitution is the supreme law, and all institutions function according to it.
2. **President as the Executive Head** – The President is the head of state and government, directly elected by the people.
3. **Separation of Powers** – The USA follows a strict separation of powers among three branches:

Executive – The President and the Cabinet.

Legislature – The Congress (Senate and House of Representatives).

Judiciary – The Supreme Court and other courts.

4. **Fixed Tenure** – The President serves a fixed term of 4 years and can only be removed through impeachment.
5. **Independent Judiciary** – The judiciary is completely independent and interprets the Constitution.
6. **Federal System** – The USA follows a federal structure where states have a high degree of autonomy.
7. **Weaker Party Discipline** – Members of Congress have more independence, and party control is less rigid.

3. Key Differences Between the British and American Systems
